This scorecard is an audit tool of qualitative information and a product of #uproot, a youth-led political agenda to end AIDS by 2030. It was completed by and reflects the views of the young people most affected by the HIV epidemic regarding their country's progress in fulfilling the promises in the 2016 Political Declaration on HIV/AIDS. It was completed through a moderated, inclusive and safe discussion with young people using a set of guiding questions related to laws and policies, access to services, participation, partnerships and leadership in the context of HIV, and existing and available data at the country level.
